Annual Report From UCCH Moderators

The past year has been a year of high activity as well as of significant transitions. The following summary lists a few of the highlights coordinated by your Church Council and our Pastoral Transition Committee, as a reminder of how the Holy Spirit is active in our midst.

- June 4, 2017 The congregation voted to allocate the final portion of Light on the Hill funds as follows: increase funds for building enhancements from \$45K (voted in October of 2016) to \$95K, allocate 25% of the expected remaining funds (approximately \$228K) to the existing Capital Expense Reserves fund, and the remaining 75% to be set aside for Future Capital Expenses, following completion of the strategic planning process. The building enhancements included replacing the narthex doors, opening up the lower kitchen area, building benches in the garden and patio areas, adding a beverage credenza to corridor 222, and creating a reception area by the main office.
- July 1, 2017 The post-Edens period became official, as Susan Steinberg took on the role of acting Head of Staff, David Mateo increases his hours and responsibilities as he becomes the staff liaison for the Board of Justice, Outreach and Service (BJOS), and Aly Breisch increases her hours in support of pastoral care. Anitra Grove continued as Acting Director of Children's Ministries and Katherine Henderson as Acting Director of Youth Ministries.
- September 1, 2017 Nick Carter joined our staff as Acting Pastor for Worship and Stewardship to assist with worship and church administration.
- September 30, 2017 –Susan Beaumont conducted a workshop on "Leading in the Liminal Time"
- October 2017– After reviewing 60 profiles, listening to dozens of sermons, and interviewing 5 candidates onsite, the Pastor Search Committee identified Reverend Cameron Barr as its unanimous choice for our next Senior Pastor. During a congregational meeting on October 29, the congregation voted to postpone presentation of the 2018 budget until December, after the compensation package for Reverend Barr was completed and he was officially hired.
- November 19, 2017 Following a weekend of getting to know Reverend Barr, the Congregation voted to extend a call to Rev. Cameron Barr as the next Senior Pastor of UCCH.
- December 10, 2017 The congregational adopted the 2018 budget.
- January 28, 2018 A farewell reception and love offering were held to celebrate Mary Beth Peterson, who is leaving the organist position after 19 years.
- March 5 Cameron Barr joins the staff as the new Senior Pastor, Susan Steinberg transitioned to Director for Faith Formation while assisting in Cameron's orientation and Nick Carter returns to his role as congregant and retiree.
- May 6, 2018 Celebrated the ministry of Aly Breisch, who will retire at the end of May after serving as the Parish Nurse for UCCH since 2001.
- June 2, 2017 Susan Beaumont will lead her final Leadership workshop for church staff and lay leaders.

It has been an exciting 12 months and we continue to be humbled by the gifts and dedication of the staff and congregation. Thanks be to God.

Board of Adult Education Annual Report: 2018

Throughout the program year, the Board of Adult Education coordinated a wide range of offerings focused on deepening UCCH members' faith and supporting members' witness in the world. UCCH Library Activities: Wildemuth, Barbara M

The Library now holds over 4200 items in its adult, children's, and audiovisual collections. During 2017/2018, 599 items were added to the collection, many of them donations from Rick and Jill Edens. In Fall 2017, proceeds from that year's and past book sales were used to purchase one new set of shelves, a new end table, and a rug for the newly-developed children's. With the renewed staffing this past year, library use is higher than ever. During 2017, 385 items were borrowed; on average, 32 items per month.

Board of Children's Ministries Report for 2017-2018

Working with our Acting Director of Children's Ministries, church staff and wonderful congregation we focused on supporting the faith formation of our children and families.

Staffing

Anita Grove continued to serve as Acting Director of Children's Ministry throughout the year.

Program content

Our Sunday School curriculum focused on following the Revised Common Lectionary using the Spark Lectionary Curriculum as well as Progressive Christianity Curriculum with a focus on opportunities to put faith into action. The VBS theme was Peace Be with You, focusing on Peace from within, Peace in our community, Peace with creation, and Peace as an offering.

Special Events

Children's Ministries welcomed Cameron Barr with a welcome poster and video.

Core Programing

Weekly Sunday School, September to May, for 126 children in 5 different age groupings. 18 teachers were recruited and trained. Meetings were held to review curriculum and exchange ideas. Teachers use the Spark Lectionary Curriculum and our 4th/5th grade room also uses the Progressive Christianity curriculum.

Sunday School programming includes five *Children's Church services* per year. These services are led by each Sunday School age grouping with music volunteers and children's music groups.

Weekly Sunday School offerings went to Church World Service and Safe School Zones (http://church.cwsglobal.org/fund-a-program/school-safe-zones/). Sunday School children also donated supplies and/or letters to flood relief in Ocracoke, TABLE, IFC, Project Home start, the Diaper Bank, Prison Ministries, and congregational members that are homebound.

Weekly nursery care was provided for an average of twenty infants, toddlers and young children, staffed by a director, assistant director and three attendants.

Weekly Faith and Family Class

The group, facilitated by volunteers, read the following book to guide their discussions: Get Out of My Life, but First Could You Drive Me & Cheryl to the Mall: A Parent's Guide to the New Teenager by Anthony E. Wolf and also focused on issues and current topics related to parenting.

Worship bags and book cart are offered for weekly worship services.

Worship services include a children's component; children's message, musical offering, or involvement in the service by children.

Youth and Young Adult Ministries Annual Report 2017-18

In the 2017-18 programming year, Youth Director Katherine Henderson and the Board of Youth and Young Adult Ministries ministered to the youth of UCCH (grades 6-12), offering education, worship, spiritual formation and care, and recreation. The Youth Director also assisted the volunteer leaders of the Young Adult Ministry in providing programming for the 20s/30s group.

Youth Group

Attendance during this program year increased to 12-15 for regular gatherings (11am on Sundays), up to 25-30 for special events including the fall and spring activity group series. Over 50 youth contributed to each Youth Church.

MUSIC COMMITTEE ANNUAL REPORT 2017-18

Music Committee

The Music Committee under the Deacons supports the musical programs and worships of the United Church of Chapel Hill. The Music Committee spends its meeting time on issues of budget, how to achieve projects sharing the many musical opportunities for worship with the congregation, and the directions of the music program to best help all to worship more fully through God's gift of music.

Director of Music (Jenny Anderson)

This year our organist of 19 years, Mary Beth Petersen, departed from UCCH in January. Julie Mitchell, Renee McBride, and Bea Price have played services in the interim on organ, and Charles Bradshaw and Gillian Fields have led services on the piano.

Light on the Hill Capital Campaign funds were used to complete the long-awaited upgrade on the organ. The organ now has the capacity for multiple organists to maintain a wide range of piston presets and it can be plugged in to one of two power and data points on either side of the chancel platform, thus allowing it to be played from anywhere in the chancel area. The organ bench was converted to an adjustable bench allowing easy change of height for various sizes of organists, and the wood of the bench and console were stripped and beautifully refinished. A small drawer was added to the console.

CHORAL OFFERINGS

The **Children's Choir** includes ages 4 through 5th grade and attendance ranges from 15-25. They led worship in 5 services, participated in Lessons in Carols and on May 6 will do a musical "In the Image" by Mark Burrows at the 8:45 service. I noted at least 7 adults who have led the children and contributed their own musical gifts to make this a true intergenerational activity.

The **Youth Choir** began the year with 29 and ended with 31 youth. They ranged in age from 5th to 12th grade. They sang for most 8:45 services on second Sundays and joined in other services of worship. Gillian Fields joined them this year as Jenny's assistant and does an excellent job. In addition, other adults have helped including teaching Voice for Life classes in which several have earned awards.

The **Chancel Choir** continues to provide music for at least three services a month. Some changes in scheduling have been tried in an attempt to attract new and younger members. Evaluation will be ongoing.

The **Chamber Singers**, directed by **Larry Triplett** is a group of 12 singers that sing classical music in acapella style. They sing once a month.

The Commas is a small group composed of members who love close harmonies from various traditions including gospel, bluegrass and older hymns.

MUSIC WORSHIP IN MULTICULTURAL CONNECTION

United Voices of Praise (UVOP) which has continued this year as it has for many years as a Christian and Musical connection with Fisher Memorial Holy Church of America under the leadership of Charles Bradshaw and Vera Bennett, Brad Kintner and Odessa Shaw. The choir sings one Sunday a month at UCCH and one at Fisher. The Community Gospel Choir was a drop-in choir which sang two services under the leadership of Greg Milton, director of the Duke University Gospel Choir. A different venue

under the leadership of Charles Bradshaw as pianist and Regina Dozier as soloist was a **Jazz Sunday** at the 11:00 service following Easter. All music, including hymns and service music was done in a jazz style. It was well received.

Our **La Mesa service** at 11:15, led by Rev. David Mateo is oriented to diversity through word and music. David has often played guitar and shared Hispanic music along with participation of many other soloists, instrumentalists and singers. Among them, Regina Dozier, Efren Maldonado, Alex Brodie, Kelly Fairman, Renee McBride, Maria Ruiz, Louis Ramos

The **Karen Choir** is a group of 20-40 singers who provide music twice a year at the 8:45 service. We learned of this group because we supported several families who fled persecution for their Christian beliefs in their native land. We are blessed, not only by their music, but by their example of faith.

INSTRUMENTAL OFFERINGS

UCCH has several groups playing **Handbells**. This year we are blessed to have David **Murphy** who became the director of **Bronze Voices**, our more experienced group, and **Chancel Bells**, a less experienced group of ringers. Both groups play regularly at worship. In addition, we have offered a **Handbell Camp** for young people from rising first grade to 10th grade. Several adults help lead this workshop and the youth play on Sunday. This year's camp was held in August and next year will be in July.

Strings are another instrumental group offering worship through music. The members comprise a range of ages and experience. The Ensemble generally rehearses on second and fourth Sundays after the 11 am worship service at the church. Rehearsals for the fall of 2018 will begin in late July or early August. The Ensemble welcomes new string players; they may contact Jack Allen, director, johannsva@mac.com for information about the ensemble. In addition, several youths have shared their string skills in worship, the youngest being Baxter and Owen Henderson.

Other instrumental groups supporting UCCH's music ministry include United Brass under Doug Zabor. This small ensemble had a quiet year due to Doug Zabor's illness, but have played several services, most recently in celebration of Easter. The Ambassadors' is a band that originated at UCCH. Larry Triplett is the current leader. This group plays for many events in the community and plays yearly for our Valentine Dance whose money intake helps to support our music program. In addition, various individuals share solos in worship on woodwinds and brass.

EVENTS AND SPECIAL SERVICES

Once a month a **Taize Service** under the leadership of **Jack Mitchell** provides an evening service of prayer, chant, and the use of icons following the Eastern Orthodox tradition.

Finally, the music program supports many **special events** which raise money for worthy causes within the community. This year we had **concerts** by the Old North State Brass to **support our Peacemaking Scholarship**, the Bradshaw Quartet for **IFC**, the Sun-Stipe-Rice Piano Trio with strings for the **Refugee Support Center**, and the Youth Choir Concert hosted at Binkley Memorial for **Josh's Hope Foundation**.

BOARD OF JUSTICE, OUTREACH AND SERVICE

2017-2018 ANNUAL REPORT

As UCCH has been in transition over the past year, so too has been the Board of Justice, Outreach, and Service (BJOS). We have maintained our commitments to community partners as we have begun a process of discernment to plan our future. Both our current and future commitments are grounded in the core values of our faith, our church, and our board – love of neighbor; love of children; love of creation; open and affirming; economic justice; and racial truth, justice, and reconciliation.

Significant efforts have been made and are planned to help the church discern how to best focus our talent, time, and treasure within the framework of our core values. Through two Justice Summits and two adult forums, members of BJOS and associated leaders, have helped the church explore the barriers and facilitators to engagement in justice work. As part of this process, church members have challenged each other and the church as an organization to grapple with issues of justice versus charity. We will continue this conversation over the coming year and look forward to the courageous conversations and spirit of curiosity our members bring to this work.

As a church and a board, much of our time, talent, and treasure is committed to supporting and loving *all* our neighbors. Specific activities over the past year include the following...

Love of Neighbor

- We were honored to work on two Habitat homes in Orange County and support two of our Karen family church members in acquiring Habitat Homes. As part of Building Hope, UCCH contributed volunteers and \$10,000 to build a beautiful new home for Gerardo and Illail Tengono. They will be welcomed to their new home with gifts made by the UCCH Quilt for Love group. We supported Mya Aye and Eh Pee, moved into their newly renovated home in the Northside neighborhood and committed an additional \$10,000 plus volunteers to build a home for Per Ser and Mue Paw in Mebane.
- The Prison Ministries group provided fellowship and meditation to men in Orange Correctional Center (OCC). The group also led three adult forums and raised \$5,500 to help fund the OCC Chaplain's salary.
- We celebrated "extravagant welcome" by supporting the Refugee Welcome Center and committing to ensure all those who seek sanctuary at UCCH will find safe passage to one of NC's established "sanctuary churches."
- We supported the Honduras mission trip and financially supported a Honduran immigrant's visa application process.
- The Alternative Gift Market contributed \$9,000 to the InterFaith Council and \$13,000 to Church World Service for a safe school zone project in Kenya.

Love of Children

- The Prison Ministries group collected more than 400 books for Parent Day at OCC. Children could pick out and take home as many as they liked.
- UCCH was pleased to again provide two Peacemaking scholarships to area youth.

Love of Creation

• The Earth Ministries committee continued efforts to reduce the church's carbon footprint by 58% (equivalent to 119 tons/year less CO₂). This year's upgrade included transitioning to wi-fi thermostats and converting part of the building to a zone system.

Open and Affirming (ONA)

• In addition to meeting regularly in fellowship, ONA sponsored the screening of the movie: Forbidden: Queer and Alone in America.

Economic Justice

- UCCH continues their commitment to Orange County Justice United (OCJU) as an "institutional member" which involves both financial and organizational support. In 2017-2018, worked to obtain a commitment for sustainable, affordable housing units and hiring a more diverse faculty and more Spanish-speaking Guidance Counselors in Orange County Schools.
- UCCH sponsored an event for the Coalition of Immokalee Workers a worker-based human rights organization that works to increase social responsibility and reduce human trafficking and gender-based violence at work.

Racial Truth, Justice, and Reconciliation

- Participants in the Sacred Conversations of Race (SCOR) have actively engaged in the discussion
 of discernment within BJOS by participating in each of the Summits and leading one of the adult
 forums. The forum examined the concept of intersectionality interacting systems of power and
 oppression within the framework of UCCH's Covenants of: Open and Affirming; Economic
 Justice; and Racial Truth, Justice, and Reconciliation.
- SCOR also began a series of conversations with other church groups, such as Prison Ministries, to begin to explore how their work and faithful commitments intersected and could be strengthened.

In addition to the time and talent committed above, the BJOS budget financially supported: NC Council of Churches, NC Inter-Faith Power & Light, Bread for the World, Justice United, NAACP-NC, HKonJ, NC Child, ONA/Pride/LGBT Local Advocacy, Peacemaking Scholarship, Orange County Literacy, St. Augustine Literacy, Inter-Faith Council for Social Service, Alamance-Orange Prison Ministry, Prison Ministry Support, Habitat for Humanity of Orange County and Stop Hunger Now.

In the fall, UCCH joined with Building Hope, a coalition of churches including UCCH, to build a beautiful new home for Gerado and Illail Tenongo. They will be welcomed to their new home with a set house warming gifts made by the UCCH Quilt for Love group. UCCH members, Mya Aye and Eh Pee, moved into their newly renovated home in the Northside neighborhood in March and were provided with furniture and other supports to ease their transition. Finally, UCCH decided to commit to a second house build for members, Per Ser and Mue Paw, also in Mebane. More than forty church members have contributed to the building and lunches this year. This second build involved not only assurances to Habitat for labor but an additional \$10,000. Due to the generosity of our members, we were able to meet this commitment. And, it has been a lot of fun to build with and for our community!

Supported Justice United, Strengthening our UCCH advocacy efforts, Crop Walk, Peacemaking/Quaker House

Supported forming of group to consider the Sanctuary movement and immigration status concerns and initiated work on developing an application process for grant approval

Supported startup of BJOS Racial Covenant Committee based on the Racial Truth, Justice and Reconciliation covenant and the efforts of Sacred Conversation on Race (SCOR) ONA- screening of movie: Forbidden: Queer and Alone in America

Supported the Honduras trip and financially supported a Honduran immigrant's visa application process

Board of Membership, Engagement and Stewardship

Membership, Engagement, and Stewardship (MES), are key components in maintaining and sustaining a vibrant, productive church community. As the MES Board of the United Church of Chapel Hill (UCCH), we are pleased to help ensure a welcoming environment to our members, friends and visitors, orient new church members; assist our members with matching their interests 'and talents with the church's needs; and lead our annual stewardship pledge drive.

As the MES board, we have been impressed and humbled by the generosity and kindness of our congregation, a true testament of the value our church and its work, has on all our lives. The 2017-2018 annual stewardship drive, which centered on the theme of, "The Journey of Faith," resulted in a total pledged amount of \$812,402. This is slightly below the goal of \$865,100. This is not entirely unexpected, given that 2017-2018 was a transition year. We received invaluable support during the stewardship campaign from the pastors and staff. Special thanks to Nick Carter and Rinnie Orr for their support and advice.

As a board, we continue to offer a welcoming presence in the church lobby that we call the UCCH Visitor Welcome Center. An MES member is present on Sundays at our "Welcome - Got a Question?" table to answer visitors' questions and to facilitate their introductions to our pastors. Also, during the past year we have had a focus on improving "signage" in the church. The video screen outside the office area is one result of these efforts.

The role of MES in equipping UCCH to engage our members' time, talents, and financial resources applies to all our members. You can make a big difference by welcoming visitors and by inviting people to a deeper participation in the life of the church.

We were thrilled to welcome Cameron Barr to UCCH and to the MES board in March. Cameron will be the staff liaison to MES. One immediate change is a new initiative to give a "more extravagant welcome" to people interested in church membership, or in learning more about our church programs. This will take the form of occasional dinners, the first happening in May.

The Board of Trustees has the overall responsibility for supervision of the finances and the property of the Church. The Board of Trustees is responsible for the following activities:

- Oversight of the annual Church operating budget and analysis of the actual financial results with respect to the budget
- Counting and depositing weekly offerings and payments to designated accounts
- Reviewing the annual financial review by outside auditors and subsequently adjusting procedures
- Approving funds and contracts for major expenditures
- Planning for maintenance of the building and associated grounds
- Collection and management of the historical records of the church

Non-routine tasks this year have included:

- Working with Church Council to complete the goals of the Light on the Hill Capital Campaign,
- Working with the Church Council and the UCCH Personnel committee to manage an atypical financial year given the number of special staffing situations in light of the retirement of Rick and Jill Edens
- Adding transparency to the UCCH operating budget process by holding several congregation "listening sessions" to collect perspectives on church financial perspectives
- Implementing a new process for documenting observed building maintenance needs and tracking those needs to completion
- Leading multiple church work days
- Established committee to administer Edens Scholarship and awarded first scholarship.
- Initiating (with congregational approval via the budget approval) a "handling fee" approach whereby the church will retain 5% of all pass-thru offerings to help offset the administrative costs associated with processing special offerings
- Updating financial policy documents

The Board of Trustees continues to be blessed with the work of many church members who are not members of the board. Alan Johnson continues to organize outside projects on church work days and maintains the beautiful grounds of the church. Proposal presented by Pagano and Wildemuth to UCCH Trustees, 2/21/2017, and Council, 2/28/2017, to hire Dingman (†*Proposal to UCCH Church Council, 2/28/2017*); approved Communicated this decision to congregation (†*Rationale for Hiring a Professional Search Firm (for congregation)*)

Contracted with Dingman, beginning in March 2017 (†Dingman Proposal, Draft, 2/15/2017; †Dingman Contract, 3/24/2017)

Services provided by Dingman included:

Congregational Q&A session with Rich Kidd, 3/26/2017; followed by his meeting with the Search Committee

Weekly confidential updates discussed with search committee chair and available to committee members

Creation and distribution of an Opportunity Profile († *UCCH Opportunity Profile, Final*)

Distribution to the Dingman list of potential candidates, plus selected people from initial UCCH announcement list

Assistance with identifying sermons available online (video or audio); requested recorded sermons from those who had none available online

Individual informal contacts with most promising candidates identified by committee Notification of candidates who passed sermon review; they received Questionnaire and Career History form

Creation and distribution of a UCCH-specific Questionnaire and a standard Career History questionnaire

Individual video interviews with candidates selected by the committee; recorded for later committee viewing and evaluation

Consultation with UCCH Personnel Committee and Treasurer, to establish a possible salary range and informally communicate that to potential candidates

Reference checks on final selected candidate; references included direct supervisor(s), direct report(s), and immediate colleagues

General guidance related to the search process

Recruiting potential candidates; announcing the position

Discussed ways to recruit a broad and diverse pool, across gender, race, sexual orientation (beginning in Jan 2017)

Not feasible to remove this type of information from pastoral profiles prior to committee review in order to have an initial "blind candidate review", as requested by Council Identified listings of potential candidates from multiple denominations

Denomination Yearbooks (UCC 2016, online access), large congregations; Seminaries in appropriate denominations (not contacted); StillSpeaking Devotional contributors; churches providing basic support to Our Church's Wider Mission; nominees suggested by Rick and Jill Edens; ministers recommended by congregation and others outside UCCH who knew we were beginning a search

Letters/emails to initial pool of prospects, sent 2/1/2017; second wave sent 2/19/2017

(†Recruitment letter; †UCCH 4-page Intro, 1/17/2017; †UCCH Brochure)

Pool generated from non-personal sources, sent via email by Kolling

Those suggested by Edens', sent in print by Demby

Davis reached out to other UCC conferences, other denominations, and seminary leadership, 2/1/2017, per Gregg-Kearns email

Announced the position via several publications/websites, once the Local Church Profile had been completed and validated (late January 2017)

UCCH website

UCC Employment Opportunities directory on the UCC website

Christian Century, print ad in journal and 8-week online posting, \$622.55

Sojourners, 4 weeks online, \$75.00

Progressive Christianity, indefinite online posting, no charge

Identified potential candidates whose profiles were listed in the UCC database

Gregg-Kearns searched database and notified prospective candidates of opening, 2/19/2017

Skill sets included in search: Social Justice Issue Campaigns; Anti-Racism Leadership; Open and Affirming; Spiritual Direction; Economic Justice; Church Growth and Size Transitions; Environmental Leadership; Justice-LED

or Community Organizing; Just Peace Leadership; UCC History, Polity, Theology Teacher


Four profiles were identified from this search

Dingman identified potential candidates from their sources, and distributed the UCCH Opportunity Profile to those people (early April 2017; † *UCCH Opportunity Profile, Final*)

Also re-checked committee's list of pastor contacts and distributed Opportunity Profile to those on the list (excluding those who had already declined)

Process for receiving and acknowledging Pastoral Profiles

Profiles were initially received by Gregg-Kearns and then released to the search committee via McArdle (clerk)



McArdle (clerk) sent an acknowledgment letter to each candidate when the profile was received Follow-up emails sent by McArdle or Kolling († Contact Log, blank, used to track contacts with candidates)

To those dropped from consideration, as decision was made

To those still under consideration, at least once per month

Stopped accepting new profiles in early August 2017; total of 60 Pastoral Profiles received

Process for evaluation of Pastoral Profiles

Rubric for review of pastoral profiles drafted 1/25/2017 (†Pastoral Profile Scoring Rubric_BLANK; †Pastoral Profile Scoring Rubric - Extended Explanation)

The first 39 profiles received were each rated by at least 3 committee members, using these procedures. The 3 member reviewers rotated among the 7 committee members so that it was not the same set of reviewers each time.

The remainder of the profiles were reviewed by Kidd; he made a recommendation, which was then reviewed by the committee, with at least 1-2 members reviewing the full profile of any candidates rejected

Rated (1-5, by 0.5-point degrees) on pastoral qualities and experience, i.e., How likely is it that the candidate embodies the following characteristics?

Effective in working and teaching

Actively promotes social and environmental justice

Theologically progressive

Strong leadership skills

Open and warm personality

Capable administrator and staff mentor

Rated (1-5, by 0.5-point degrees) on match with UCCH strategic direction, i.e., How likely is it that the candidate will support, facilitate, and lead our congregation in the following strategic directions?

Build on social justice commitments

Increase and embrace diversity in all forms

Enhance worship experience

Strengthen our sense of community

Sustain educational excellence

The two scores were summed, so ratings ranged 0-10 (actual ratings ranged 0.5-10; when averaged over all raters, actual scores ranged 2.17-9.70)

High scores (above 8.5) were moved on to sermon review

Low scores (below 5.5) were dropped from further consideration

If average score was 5.5-8.5, additional reviewers read and rated the profile

If average score was still borderline, the committee discussed the candidate before making a decision

McArdle (clerk) notified any candidates that were eliminated from further review, beginning 2/5/2017; also sent email to those candidates remaining in the pool (†*Email sent to candidates*)

Process for sermon review

Most candidates had sermons online, available for viewing, in either video or audio; assistance with locating these was provided by Dingman

Sermon reviews began in late April 2017

At least 3 members of the committee reviewed sermons by each of the 35 candidates who passed the profile review, again with rotation of the 3 members among all 7 members on initial review

Qualitative comments related to the strengths and weaknesses of each candidate's sermons were recorded

Sermons were evaluated in terms of fit with the congregation, in both message content and delivery

In addition, each reviewer noted a recommended decision: Yes, No, or Maybe
The goal was to minimize the Maybe ratings

If Kidd conducted the Pastoral Profile review, committee members included their evaluation of the Pastoral Profile in their sermon review

If there was clear consensus among the initial 3 reviewers, the decision was accepted by the committee

If a candidate passed this review, the other committee members also viewed one or more sermons during the next phase of evaluation

Because preaching and worship are so key to a pastor's acceptance, the committee set a very high standard for acceptance

If there was not clear consensus among the initial reviewers, additional committee members viewed sermons and the committee discussed the decision

Process for Questionnaire and Career History review

A Questionnaire related specifically to UCCH's needs was developed by the committee, May-June 2017 († Questionnaire for Senior Pastor Candidates)

Sample questions were provided by Dingman; additions and changes were made by the Search Committee

The goal was to keep the final questionnaire to ~10 questions

Career History form is a standard questionnaire used by Dingman

It covers all past work experience, including details of the size and structure of each church and the reasons for leaving that position

Questionnaire and Career History form were distributed by Dingman, to each candidate who passed the sermon review (n=14, minus three who withdrew at this point)

All committee members reviewed all the Questionnaire and Career History form responses (June-August 2017)

Each evaluation was recorded as 1-3 positive aspects of that candidate's responses and 1-3 concerns about that candidate's responses; these reviews were collected via an online questionnaire

Once all committee members had completed their individual reviews, Wildemuth consolidated the reviews for each candidate in a summary document, organized by theme (e.g., strong preaching skills or weaknesses in administrative background)

The consolidated reviews provided the basis for committee discussion of the candidate Based on this review and discussion, 8 candidates were selected for preliminary video interviews

Video interviews conducted by Kidd (Dingman)

Interview questions were developed by Kidd and the committee (June 2017)

Kidd provided an initial set of draft questions, used regularly by Dingman

The committee edited and added to that set of questions

The committee could also suggest questions customized for a particular candidate

The interview guide († Video Interview Questions, Final) included questions on the candidate's:

Career history and character: review of career history, handling conflicts, significant mentors

Competence: leadership and management style, approach to pastoral care, reaching the next generation of congregants

Chemistry with the UCCH culture: UCCH strategic priorities, moral challenges for the church today, facilitating the transition after long-term pastoral leadership

The interview was expected to take about 1 hour; the video recording of each interview was made available to the committee via a password-protected drop box online

On-site interview conducted by the Search Committee

A standard schedule was used for the five on-site visits/interviews

Arrive by mid-afternoon on day 1; Informal dinner with committee

Early morning/breakfast interview with committee, followed by meeting(s) with Steinberg and Mateo and tour of the UCCH facilities; lunch with Pagano and others available, if candidate is available before departure

UCCH staff were asked to maintain confidentiality of any candidates visiting Financial/logistical arrangements

Spouses or partners were invited to accompany candidate (but not children); participate in day 1 dinner, day 2 tour of the facilities and lunch; other activities to be arranged

Restaurants used for committee dinners: Weathervane, Acme Grill, City Kitchen, Squid's

Breakfasts: Bagel sandwiches brought in from Bagel Bar

Hotel: Hampton Inn, Carrboro (UCCH paid for up to 2 nights)

Air fare: UCCH paid for candidate and (optional) accompanying spouse or partner

Committee provided airport pick-up and drop-off, and all local transportation; if candidate wished to rent a car, they paid for it themselves

Demby, assisted by Duane Gilbert, worked with candidates on these arrangements She began scheduling interviews in early August, as first candidates passed the Questionnaire and Career History review

Our goal was to schedule all on-site interviews as close together as possible Pagano provided each candidate with information about the community, from Chapel Hill Visitor Center

Original target was to conduct only 4 on-site interviews, but 5 candidates were selected for on-site interviews

Developed interview guide for each candidate, for on-site interviews

Most questions were standard († On-site interview guide template), but customized as needed

Each question was asked by a particular committee member

Time was allocated for each candidate to ask us questions; approximately 1 hour for our questions and 15 minutes for candidate questions

Final evaluation process

Evaluation based on on-site interview, plus all materials provided earlier

Rubric was parallel to the initial rubric used for candidate profile review (†Evaluation Characteristics for Ministers, final version)

Committee tried to be consciously sensitive to implicit bias in our reviews, including recency and primacy effects (i.e., possible bias in favor of a candidate because they were the most recent interviewed or the very first interviewed)

Committee discussed first two candidates, after their visits; then discussed all candidates after remaining three site visits (Oct 23, 2017)

Committee came to agreement on Cameron Barr as our selected candidate Oct 23, 2017, and phoned him that evening

Kidd completed reference check; Davis checked with his conference minister
Pagano informed Alecia Brower (moderator) and Gaylen Brubaker (assistant moderator)
of our recommendation; Brubaker (chair of Personnel Committee) negotiated specific
terms for the appointment, approved by the Trustees

A 2-page summary of candidate qualifications (†*Barr Nomination, final*) was provided to the Council, with the committee's nomination; the nomination was approved by the Council on Nov 11, 2017

Hiring process

Handled by the Personnel Committee (chaired by Gaylen Brubaker), the Treasurer (Derek Harrison), and Duane Gilbert

The Search Committee was not involved in this final step

A Letter of Agreement was approved by the Trustees

Draft letter (without compensation details) was approved in advance

After Search Committee offered the position to Barr, compensation (i.e., salary, housing allowance, other compensation, benefits) was negotiated with him by the Personnel Committee

Trustees approved the final Letter of Agreement, with compensation details, in late October/early November

Candidate weekend, coordinated by the Pastoral Transition Committee

None of the current Associate Pastors were called by the congregation, so we had no precedents to follow

Pastoral Transition Committee handled the arrangements for the candidate visit and worship leadership, Nov 19, 2017

Saturday, November 18, 2017

9:30-10:30, Barr met with church staff

11-12, Barr met with Council

2:15-3 and 3:30-4, Barr met with congregation members

Sunday, November 19, 2017

Barr preaching at both 8:45 and 11 services; he was introduced during Children's Church at 10

Congregational meeting, noon

Note: The Alternative Market was also happening during the same weekend, so parking needed to be coordinated.
