- Thirty fewer families pledged in 2022.
- In an effort to better understand giving cycles, the Stewardship Board will implement the following plan:
  - Collect data on giving patterns over the last five years.
  - Communicate information to groups.
  - Draft and target correspondence to church members.
  - Continue with the Storytelling Project.
  - Schedule fun and inclusive events.
- Jane Landreth, Clerk suggested that it might be beneficial to contact the Stewardship Boards of local Chapel Hill and Carrboro churches to identify pandemic financial strategies that have worked or not worked for them.

**Financial Report**

Upcoming Activities:

- On March 5, 2022, baby items will be collected at the church for the refugee support community. MES will serve coffee and donuts.

**Board of Justice, Outreach, and Service**

**Larry Kroutil** reviewed the current status:

- The Afghan Resettlement Committee will sponsor a Shrove Tuesday Pancake Dinner on Tuesday, March 1, 2022.
- Church World Service (CWS) is still in the process of vetting team members. This has been delayed due to a large positive response.
- Cameron Barr discussed the possibility of inviting Dr. Wilma Gaffney to UCCH for a Racial Justice weekend; workshop on Saturday and preaching and leading a forum on Sunday.
- The [Durham Pilgrimage of Pain and Hope](#) will occur on July 15 – 17 for the members of UCCH.
- BJOS and the Music Committee are working on a proposal to educate the congregation about Negro Spirituals that we sing that were written by enslaved people.
- BJOS is experiencing issues recruiting members to serve; at the end of the year, there will be only two returning members for 2022 – 2023.

**Children's Ministry**

**Alyson Breisch** reported the following activities:

- In February, 2022, Children's Ministries participated with Mary Elizabeth Hanchey, Associate Pastor to create and deliver valentines.
- Reviewing activities to plan during Lent; will consider sending kits home to children.
- Discussing how to support and participate in the Good Friday service on April 15, 2022.
- The Crop Walk is scheduled on April 3<sup>rd</sup>; Melanie Joyner is assisting in the planning for church participation.
- Creation Camp Vacation Bible School (VBS) will be held from July 21 – August 4, 2022. Sixty to seventy volunteers are needed to assist in VBS activities.
- UCCH will participate in the multi-generational [Rise Against Hunger](#) event on Saturday, May 14, 2022 from 10 AM – 12:00 Noon. Rise Against Hunger volunteers will come to UCCH with food. UCCH volunteers will bundle the food. Funding options include:
  - Approve the fundraising plan submitted by Children's Ministry.
  - The \$5200 will be paid for with funds not currently in the budget.
    - There is \$21,000 in the Mission Outreach Fund; this is interest earned that is sitting on the balance sheet. Larry Kroutil will meet with Duane Gilbert and Cameron Barr to discuss and develop a clear process for distributing funds. Once completed, will be documented in the Trustees' Financial Plan. Cameron requested that Children's Ministries create a funding proposal, circulate to the Council via email and Council member will approve by email.

**Deacons**

**Peter Schay** reported on the results of a six-month debriefing conducted with the Board of Deacons

Results:

- The last six months demonstrated the flexibility of the Deacons responding to the uncertainty of in-person worship.
- Communion practices evolved.
- A different source of gluten free bread was identified.
- A process was implemented to allow church members to volunteer ad hoc to take the altar flowers to a congregant worshipping at home.

Challenges to the next six months:

- Unpredictability of COVID spread.
- Finding members to serve as a Deacon.
- Reinstate structure in Deacons signing up for ushering.
- Rebuilding in-person attendance.
- Will need volunteers for online video streaming when it is implemented.
- Would like to set metrics for tasks within the Deacon's span of control.

**Music**

**David Taylor (Chair of the Music Committee)** reported on the results of a six-month debrief conducted with the Music Committee:

**Successes:**

- Staging the Joseph and the Multi-Colored Dream Coat musical.
- Memorial Service for Victoria Adeleke.
- Christmas **Lessons** and Carols.
- Inventiveness of the music staff and substitute organists.
- United Voices of Praise (UVOP) was able to work out a plan to perform once a month while accommodating the change in worship schedule.

**Improve:**

- Fill the organist position.
- Improve music support for La Mesa.

**Goals:**

- Enhance the music experience.
- Provide an opportunity for church members to learn about and participate in the music program.
- Solicit feedback from the congregation about the music program.

**Appendix 1**  
**2021 Year End Treasurer's Report & 2022 Budget Update**  
**From February 22, 2022 ENews**

Doug Bruce, our Treasurer, is very pleased to report that 2021 closed out better than expected with a very high level of giving in December. He also shares some changes that have been made to our 2022 budget based on expected income. Here's the summary:

**2021 Budget:** Although we began 2022 with a deficit budget of approximately \$13,000, we finished the year with a surplus of more than \$31,000.

**Designated Funds:** We received and recorded \$80,306 in 2021 for specific use funds.

**Endowment Funds:** The value of our Endowment Funds grew from \$888,219 at the beginning of 2021 to \$969,786 at the end of the year.

**Virtual Alternative Gift Market:** The online market had sales of \$8,891, which support various ministries including Church World Service and IFC.

**2022 Budget Update:** Our 2022 budget, which was approved during our congregational meeting on November 3, 2021, was based on the receipt of \$925,000 in pledges. However, the actual pledged amount totals \$850,000. Due to this shortage, the Church Council has approved reductions in budgeted expenses from the original amounts approved by the congregation. The changes defer a number of re-engagement initiatives, reducing the affected budget items back to their 2021 budget levels, including:

- Personnel (\$6,500)- positions not yet filled
- Deacons and Music (\$12,000)- interpretation, musicians, music capital reserve
- Children and Youth (\$9,000)- curriculum, special programs, scholarships, trips
- Board of Trustees (\$19,500)- virtual/technology, printing, postage, office supplies/equipment
- Building and Grounds (\$11,600)- supplies, maintenance, utilities, grounds

These changes largely take the affected budget items back to the 2021 budget levels.
